Responsibilities of Trimmed Innovations:

- 1) Filing one patent ever month year for Techno NJR. The filing process includes receiving of invention, substantive intellectual property search performed via paid search engines and specialized process, drafting of application including claims & finally filing application and rendering patent application number (also called patent pending number). Filing will be done by our Patent Consultant, Dr. Vijeta Jha. She is NASDAQ listed Eureka's Speaker/Mentor, Eureka 2019-20, ECell, IIT Bombay; Co-Facilitator TechFest Workshop NanoMachines 2019-20, IIT Bombay; Session Leader, Zoom Pgrm 2019-20, Patenting, IIM Udaipur Incubation Centre, IIM Udaipur. Patent Applications be provided by either Techno NJR and/or very high rated innovations unpatented/unpublished bank of Dr. Saurabh Kwatra (Trimmed Innovations).
- 2) Giving one technical workshop of 2/3 days every month exclusively for students of Techno NJR at almost cost price of equipment and hardware. This is limited only by number of students that can be taught best without compromise on quality.
- 3 Filing German Utility Models in Germany as advised by Techno NJR at actual charges.
- 4) Answer to any Patent related queries by faculty/students in area of IP by Dr Vijeta Jha as she be working dedicated for Techno NJR.

Remunerations:
