We are pleased to inform you that you have been offered for **Embedded Engineer** position. Your direct reporting will be to **Mr.Rakesh Kumar**, you are assigned to and will be initially based at Bangalore; however your work location may be changed to any of our other development facilities or our client locations. You will be required to travel across India and overseas as and when required. Yourjob responsibilities and reporting structure would be explained during your induction and they are subject to change as per the management decisions from time to time. Your appointment is subject to following terms and conditions:

- Your position would carry a gross compensation (total annual CTC) INR 4,87,300.00 (Rupees Four Lakhs Eighty Seven Thousand Three Hundred Only), effective from the date of appointment. Details of your salary structure (Annexure-1) is enclosed along with this letter.
- 2. You shall be Probation for a period of Six Months from the date of joining for Duty. The duration of probation can be extended subject to your performance which is at the discretion of Management. Your service shall be confirmed in writing to that effect, in the appropriate position satisfactory completion of probation, failing which you will be deemed to be on probation.
