

#### **Abstract**

On March 08, 2024, the Techno NJR Institute of Technology hosted a stimulating debate competition on the topic "Gender Quotas in Leadership Roles." The event took place in the Seminar Hall from 2:00 PM to 3:00 PM and saw an engaging exchange of ideas among the participants.

could undermine merit-based selection and lead to tokenism. They argued that leadership roles should be filled based on competence and qualifications, rather than fulfilling a numerical quota. They also expressed concerns that quotas might reinforce stereotypes rather than challenge them.

The debate was engaging, with participants presenting well-researched arguments and responding to counterpoints effectively. The audience actively contributed, adding depth to the discussion. The judges commended the participants for their articulate arguments. While no consensus was reached, the event encouraged critical thinking on the complex issue of gender quotas in leadership, highlighting diverse perspectives and the importance of gender equality in modern society.

can lead to chronic stress, burnout, and anxiety.

He also brought attention to the impact of trauma, such as domestic violence and sexual abuse,

on women's mental health, stressing the need for trauma-informed care.

3. Stigma and Barriers to Seeking Help:

A significant part of Dr. Bishnoi's speech focused on the stigma surrounding mental health,

especially for women. He noted that many women feel hesitant to seek help for fear of being

- He advocated for better mental health services tailored to women's specific needs, including
  access to therapy and support groups for conditions like postpartum depression and traumarelated disorders.
- He concluded with a call to action, urging the audience to support mental health initiatives, promote self-care among women, and challenge societal norms that contribute to mental health struggles.

#### **Conclusion:**

The seminar concluded with an engaging Q&A session, where Dr. Bishnoi answered questions from the audience. Topics included strategies for coping with stress, how to support women experiencing mental health issues, and the need for policies that promote better mental health care for women.
